



Owyhee Cattlemen's Association Beef Heifer Replacement Program

The Owyhee Cattlemen's Association (OCA) is interested in promoting educational and financial opportunities that are relative to the beef industry to Owyhee County youth. In doing so, the youth who participate will gain knowledge and experience in selection, feeding, breeding, exhibiting and marketing livestock. It is the intent of OCA that the youth will build his/her breeding herd in order to receive financial and educational benefits.

Who is eligible to receive a heifer?

1. Youth must be in the 5th through 10th grade at the time of application and must be an Owyhee County 4-H or FFA member.
2. Heifers may be given to youth, depending upon the number of applications and availability of heifers, subject to the discretion of the Board.
3. Priority will be given to youth who have not received a heifer from the program; however, participants may apply as many years as they wish.
4. Youth will be interviewed prior to selection from the applications.

Requirements of the Youth:

The youth must:

1. Complete an application and submit it to the Extension Office by June 1 of the current year.
2. Have adequate facilities or a suitable location to keep the heifer.
3. Provide the feed for the animal. Heifers should be fed for continuous growth, gaining approximately 1-2 pounds per day.
4. Be a member of OCA to receive a heifer.
5. Attend the OCA summer meeting for awarding of the certificate to receive a heifer.
6. Pick up the heifer from the donating producer.
7. Be solely responsible for the care and management of the female. All calves the female produces will belong to the youth.
8. Have the female bred at the appropriate time to a quality beef bull, and have facilities for calving.
9. Attend the OCA summer meeting for two years after the heifer is received, and present a short update on the breeding project.
10. Maintain written records in order to document the management of their heifer project. Completion of record books is mandatory. These written records must be submitted to the Owyhee Cattlemen's Association prior to exhibition at the fair.
11. Prepare and exhibit the heifer as a yearling and, again, as a cow-calf pair the following year at the Owyhee County Fair. This participation is required.

Heifer Eligibility and Ownership:

Purebred and crossbred heifers are eligible. Heifer must be structurally sound, current on vaccinations, including brucellosis, and polled or dehorned to ensure safety. The heifer must be of a beef breed and show no signs of dairy or rodeo breed influence. Females who were born twins to a bull are ineligible for the project. Any open, weaned heifers are eligible. Final approval will be made by the Owyhee Cattlemen's Association Board of Directors.

1. If the female is sold for any reason, after all requirements have been met, the revenue generated belongs to the youth.

2. If the heifer dies, is unable to be bred, or is unfit for show at the Owyhee County Fair, the youth must contact the OCA immediately. The OCA will deal with each situation on a case by case basis, and the executive committee will make all decisions.
3. If a youth neglects to maintain their part of the contract, the heifer may be taken back and returned to the donating producer. In this event, the youth will be ineligible to apply for a heifer again in the future.

Requirements of the Donating Producers:

1. Provide a Bill of Sale to youth and transfer registration papers, if applicable.
2. Provide heifer information such as date of birth, dam ID, sire ID, breed, weaning weight and date, and vaccination records, if available.
3. Have heifer current on vaccinations, including Brucellosis.
4. Dehorn heifer, if necessary.
5. Notify the OCA Board/Extension Office by June 1 if you are willing to donate a heifer.

Calendar of Events:

1 st year	June 1	Applications must be submitted to the Owyhee County Extension Office.
	June	OCA committee will review applications and conduct interviews.
	July	Heifer certificates will be awarded to students at the OCA summer meeting.
	Fall	Participants will receive their calves in the fall.
2 nd year	July	Submit records to the County Extension Office
	July	Attend OCA summer meeting and present update on bred heifer.
	August	Youth will exhibit bred heifer at the Owyhee County Fair.
3 rd year	July	Attend OCA summer meeting and present update on cow/calf pair
	August	Youth will exhibit cow/calf pair at the Owyhee County Fair.
